REGISTRATION PROCEDURE:

Participants are divided into 2 groups: **NRL-REPs** (<u>R</u>eimbursement-<u>E</u>ligible <u>P</u>articipants from EU-NRLs) and **Non-REPs**.

NRL-REPs:

Due to budget limitations we have agreed on some rules to limit the number of NRL-REPs per country and per institution as follows:

- From each EU member state: max. 1 REP per NRL-function, but max. 3 REP per country
- From each Institution with more than 1 NRL-function max. 2 REPs
- Only one institution in one country but with all 4 NRL-function max. 2 REPs
- Only one institution in one country with all 4 NRL-function but with a member in the AQC-Group: max. 2 REPs + 1 AQC

Institutions with overlapping NRL-functions please <u>coordinate</u> to ensure that <u>all</u> above REP-limits for institutions and member states are met.

Member states and NRLs not intending to participate with the full number of possible NRL-REPs: Please contact us as soon as possible (**eurl-pesticides@cvuafr.bwl.de**), so that we can shift the capacity for additional NRL-REPs from other NRLs with needs.

<u>Flight / Rail</u> must be booked by yourself and will be reimbursed in accordance with the EU regulation (2023): Unit costs for travel, accommodation and subsistence costs (CD C(2023)4928). Please use the link "Calculate unit costs for eligible travel costs" to check the maximal travel costs that can be reimbursed in your case. Travel costs exceeding the max. refundable amount will not be reimbursed by the organisers. <u>Hotel</u> costs for max. 3 nights (Tue 23 – Fri 25 Sept.) in hotels with reservations provided by the EURL AO team will be paid directly by the organizers.

Full catering will be provided using the subsistence costs.

• Non-REPs:

These are persons accepted to participate in the joint workshop at own cost (not eligible for reimbursement by the EURLs). This includes the following:

- a) Additional persons from EU-NRLs,
- b) NRL-representatives from EU-candidate, EFTA and third countries,
- c) OfL- representatives from EU Member States (incl. commercial labs working as OfLs on behalf of EU MSs),
- d) OfL- representatives from third country labs, and
- e) Representatives from other commercial labs

The number of Non-REPs is limited. "First come, first served" principle will be applied, however, in case the number is exceeded, prioritization will apply following the above order.

Participation fee:

Non-REPs are requested to pay the <u>early bird</u> participation fee of 400 € per person.

The fee covers full catering during the workshop including the get together and two diners.

Travel and accommodation costs have to be covered at own costs.

Registration:

Non-REPs should register by Fri. 20 June, 2025 using this link Joint Workshop Registration

Late registration fee (depending on availability):

Non-REPs are requested to pay the <u>late bird</u> participation fee of 450 € per person after 20 June 2025 but until 11 July 2025 at the latest.
