Workshop and Training of the EURL and NRLs for pesticide residues in food of animal origin & commodities with high fat content to be held from 08 to 10 October 2024 in Freiburg, Germany

The following topics are currently planned for the workshop:

• Exercises for the use of SANTE document similar to those at the training in Copenhagen in June 2024

The workshop and the training course are planned to be held as physical workshop/training course and will **not** be held in hybrid mode.

3. General information

The workshop is open for **representatives of NRLs for pesticide residues in food of animal origin and commodities with high fat content** and invited experts. **One representative** from one NRL **per EU Member State** as well as invited experts will be reimbursed for participation at the workshop.

For this person (eligible participant) **unit costs** for travel, accommodation and daily allowances will be covered according to the new rules. **Non-eligible participants** will be charged a fee for lunch and refreshments during the workshop and dinner (if participating). In cases where more than one representative of a member state will attend the workshop, please inform us which person is eligible.

A workshop dinner will be organised on 08 October 2024 and a training dinner will be organised on 09 October 2024.

4. Registration

Please inform us, **if your total travel costs exceed these amounts** for **return trips** considerably.
